To whom it may concern, I am a concerned citizen who has watched Elliot Lake struggle for the past couple of years and am familiar with the past history and socioeconomic and demographic issues and challenges inherent in a community that has lost it's industrial base. I have given this situation a great deal of thought and have come up with a possible solution to stimulate growth and prosperity in Elliot Lake.

Several years ago, when working in B.C. I remember visiting a town that has very similar parameters and history as Elliot lake and has successfully grown from a situation that Elliot Lake currently finds its self in ,to a successful and diverse community with a thriving real-estate market , a diverse population and business community . The town of Kimberley, British Columbia, suffered a near economic collapse in the 90's with the closure of their mining industry and struggled with falling housing prices and an ageing population and the closure of many local businesses.

Kimberley has many similarities to Elliot Lake like population size ,beautiful scenery ,off the main highway(about 20 min), a small ski hill and a retirement population base. The town is now a thriving international touring destination with world class resorts and ski chalets, a robust housing market and a diverse and tourism oriented economic base. How did they do it?

I have worked in marketing and promotion and know the importance of image and branding to create demand. Although my expertise is not at the municipal level, the fundamentals are the same -develop your best assets and present them through aggressive advertising to create demand for your product -in this case ,a city.

I then took the initiative to contact the city of Kimberley to ask them how they managed to create such a thriving community and was directed to the sites below that describe in detail the steps that were implemented to create a new image for Kimberley and which, I can happily add, are working to attract not only tourists from all over the world both summer and winter , investment capital in real estate and permanent residents and businesses. Also the housing market has rebounded and continues to grow!

I have read the sites available for viewing online and find it to be a brilliant and viable solution that I believe would work for Elliot Lake as a template . This kind of transformation of a city costs money so I inquired as to how this was achieved with the limited budget and found that the solution required several key elements for success: first they took an iconic tourist destination image of a Bavarian ski village and recreated it in the downtown core (which by the way is about the same distance from the ski hill as is Elliot Lake's) this was done through a consensus and co-operation with the Kimberley Chamber of Commerce and a combination of volunteer work as well as paid contractors to cut costs. They also partnered with the Green Municipal Fund (a federal development grant) to help develop the ski hill and attract investment capital. Then they developed the ICSP(Integrated Community Sustainability Plan) with the help of the Green Municipal Fund. Then they implemented the "Imagine Kimberley " plan and appointed committees responsible to oversee the implementation and progress of the plan.

It is my hope that after further review of this strategy, that a similar plan can be implemented here in Elliot Lake. Here are the links to the web sites I referred to earlier that describe in great detail how this system works. Thank you for your consideration of this idea, Richard Friess.
