City of Elliot Lake: Fire Ranger Heritage Centre - Green Job Initiative

The Canadian Parks and Recreation Association (CPRA) has secured Government of Canada funding via Employment and Social Development Canada to support a "green jobs" program for youth. Officially entitled the Summer Work Experience Green Jobs Initiative, the program is providing direct financial support (via wage subsidies) to Elliot Lake for two summer student positions entitled "Fire Ranger Heritage Center Interpreters".



The Department of Recreation and Culture have hired Kayleigh Pollock and Christian Berubé as this summer's Fire Ranger Heritage Centre Interpreters for a period of 16 weeks from May 6 to August 23, 2019. Joanne Jarvis will supervise this team.





The students are tasked with creating an interpretive walking trail and programs at the Fire Tower. With the direction of 3 members of the Coureurs de Bois Outdoor Club as well as members of the Penokean Hills Field Naturalists, Kayleigh and Christian will be responsible for researching, mapping out, and developing an accessible walking trail with interpretive signage. Students will have the opportunity to learn from local naturalists while spending time in our beautiful ecosystem at the edge of the boreal forest.



Kayleigh and Christian will also create interpretive programs for kids and adults such as guided walks on their trail, and presentations about local flora and fauna. They will be able to share their new knowledge with visitors from around the world, as well as Elliot Lake's youngest generation. The program will work to engage youth and visitors in conversation about conservation, leave no trace hiking skills, and green lifestyles.

My name is Tyler Nicol. I'm a Mountain Biker from Southern Ontario. For the past 2 years, I have been building an audience on Youtube while travelling and reviewing Mountain Bike Trails. I have travelled to many of North America's best trail systems in the past 2 years.

This summer, I would like to focus on some trail systems that are closer to home as a broad portion of my audience is from Ontario. I have been scanning maps North of Lake Huron in search of Mountain Bike Trails. I figured that with a population over 10000, Elliot Lake would likely have some kind of trail system -but nothing appeared on the maps. After scanning The City of Elliot Lake's website, I found an entry claiming "Elliot Lake has hundreds of kilometres of mountain bike trails". Other than this entry - I have been unable to find any other information on these trails.

I am writing this e-mail to inquire if Elliot Lake Tourism would be interested in a partnership to bring exposure to their trail networks. I am able to bring an audience, my camera gear, labour and knowledge of trail networks. In exchange, I would only ask for monetary coverage of basic travel expenses including a car rental and the cost of gasoline.

I am genuinely hopeful to find and share the next Mountain Bike Mecca that is close to home and "hundreds of km of Mountain Bike Trails" sounds to tempting to pass up!
