NWMO REPORT TO THE COMMITTEE

Norman Sandberg introduced his NWMO colleagues and reported that the NWMO was present at the Association of Municipalities of Ontario (AMO) conference last week. He reported that the field work is complete in the Mahzabong block and a report will come forward either at the end of 2017 or in the beginning of 2018. The Chair asked if the committee could visit the Mahzabong block area and Mr. Sandberg remarked that the roads are open to the general public. Depending on the results of the reports the NWMO could have some technical staff available in that area in the future to meet with the CLC. Mr. Sandberg reported that there will be a tour on September 11th to the NWMO's Research and Development Centre in Oakville. Arrangements have been made for representatives from 5 communities in the area (Bind River, Elliot Lake, Huron Shores, Spanish and the Township of the North Shore) to visit the Centre for a total of 25 people.

Ray Hatfield spoke about the field mapping in the Mahzabong block. The mapping lasted 7 weeks and opened and closed with traditional ceremonies. Traditional knowledge and spiritual beliefs were shared by members of Sagamok First Nation. Guides from Sagamok were provided and sensitive areas were pointed out to the consultants. Ray Hatfield mentioned that if the CLC would like to visit the block that the Richie Falls Resort would be available to accommodate them for a meal, but, just give them a month's notice. He reported that Sagamok is continuing to learn more and members have visited the McMaster Nuclear facility along with the dry storage facility at Bruce Power in Kincardine and the Oakville R & D facility. Sagamok has made no commitment but continues to learn more.

Tammy Olsen reported to the committee on the NWMO's presence at local and regional events this summer. She reported that open-office events in the Elliot Lake and Blind River Learn More Centres ran July 25, 26 and 27 and they spoke to about 85 people in both locations. There was also an event in Sagamok where they spoke to approximately 15 people. They reported that they will send 2 staff to Mississagi Park's Lumberjack Days next year, as Tammy was very busy this year.

Unfinished BUSINESS

The CLC Coordinator gave a brief presentation on the NOSM STEM Camp that was offered in Elliot Lake June 24-28. When asked she recommended that the camp continue next year and expand the age to accommodate more campers.

The Committee directed the Coordinator to check some dates for Aboriginal Competency Training with Sue Chiblow and bring back dates at the September meeting.

The Chair reported that the person responsible for the City's youth committee is retiring, so he will make contact once a new person is in place regarding a youth resource to the CLC.

NEW BUSINESS

John Raniowski of the Spanish Neighbouring Committee gave a report on the sessions he attended at the Canadian Nuclear Society Conference June 4-7. The Conference was entitled "Our Nuclear Future, Renewals and Responsibility". It was followed by a brief question and answer period.

Q: Steve Meawasige asked if there has ever been any indigenous people appointed to sit on an Environmental Assessment Panel?

A: Ms. McClenaghan answered that to the best of her knowledge she didn't know of anyone. CLC Vice-Chair, Cherry Gunning then answered that she knew of someone appointed in Saskatchewan, but the person resigned before the process was complete.

Q: Steve Meawasige asked if Ms. McClenaghan would meet with his aboriginal youth group, PALS?

A: Ms. McClenaghan answered she would most certainly come to meet with his group.

Q: Michael Bennett asked if there are any differences in the wording of what triggers an environmental assessment? He also said he had more questions but he will send them to her separately.

A: Ms. McClenaghan answered that they have not got to that section yet in the review process. She said that he can send his questions to her email.

Q: Nancy Phipps said she is new to the area and she asked, is Elliot Lake looking to store waste and is there an environmental assessment?

A: The CLC chair answered that there has been no location chosen for the deep geological repository by the NWMO and that Elliot Lake is still in the learning process and therefore there is no environmental assessment process.

The Chair thanked Ms. McClenaghan.
