

#### **Background**

#### Zoning By-law 95-2003

- Adopted by Council on July 14, 2003
- Divides the Town into zones
- Specifies how land within zones may be used
- Specifies criteria for development, including:
  - Location of buildings and structures
  - Parking and functional requirements
  - Height and density
  - Lot sizes, etc.
- 41 separate zones
- 174 Exceptions
- Over 700 minor variances



- Statutory requirement to achieve conformity with the Town of Ajax Official Plan
  - Environment (OPA 38)
  - Transportation (OPA 40)
  - Intensification (OPA 41)
  - Employment Lands (OPA 42)
- Make improvements based on staff and customer experience
  - Technical and Housekeeping
  - Improve Clarity and User Friendliness
  - Implement Best Practices



#### Stable Neighbourhoods

#### **Residential and Institutional Zones**

- Ensure that zoning reflects the character of individual neighbourhoods
- Residential Parking
  - Driveways/curb cuts
- Legacy Neighbourhoods
  - Wartime Houses
  - Neighbourhood One
- Country Residential Zones
- Accessory Buildings and Structures





#### **Intensification Areas**

#### **Official Plan Conformity**

- Accommodate Intensification:
  - Centres: Downtown, Uptown
  - Corridors: Regional and Local Corridors
  - GO Transit Station Mixed Use Area
- Broaden the range of housing types
- Urban Design Principles
  - Built form:
    - Low-Rise, Mid-Rise, Tall Buildings
  - Building orientation
  - Setbacks



#### **Update and Modernize**

- Evaluate and update permitted uses

- Remove redundancies








#### **Greenlands System**

#### Implement OPA 38 and the Greenbelt Plan

- Revise mapping in the Greenbelt to reflect the approved Official Plan
- Investigate permitted uses in the Greenbelt to enhance viability
- Update performance standards in Open Space zones





#### Pickering Village

#### **Support Heritage Character in the Village**

- Tailor performance standards to support the heritage character of the Village
  - Implement recommendations of the **HCD Plan**
- Tailor accessory building permissions
- Broaden commercial and residential permissions



#### **Transportation Standards**

#### Improve/Modernize Standards

- Revise/modernize parking standards/rates
  - Improve efficiencies
    - Standards for shared parking
  - Develop standards for employment buildings with multiple tenants
  - Update parking rates in response to AODA requirements
- Include standards for active transportation
  - Bicycle parking and storage
  - Incorporate Transportation Demand Management (TDM) initiatives
- Update loading space requirements





#### **Sustainability Elements**

#### **Implement Environmental Policies**

- Include requirements for storage of recyclables in multi-residential buildings
- Permit community gardens
- Address "cool" and "green" roofs

#### **Improve Clarity and Access**


- Remove duplication by merging schedules

  - Reorganize to respond to the needs of the user
- Improve ease of access:

  - Introduce hyperlinks to enable easier on-line navigation





# What is a Development Permit System (DPS)?


- The DPS combines the zoning, site plan and minor variance processes into one application and approval process
- A one-stop source for planning approvals
- Provides greater flexibility
- "Front-end loaded"
  - Requires enabling Official
     Plan policy and DPS By-law
  - Public Consultation on the DPS is up-front
  - Conditions of development established up-front



#### **Development Permitting Implementation Study**

# What is a Development Permit System (DPS)?

- Eliminates the possibility of "third party" appeals of development applications to the OMB
- May be appropriate for all or parts of the Town
- Background and approach to be presented in June, 2015

  - Release Discussion Papers
  - Public Consultation Period begins
  - Release Online Interactive Zoning Bylaw
  - Social Media Tools

- Fall, 2015: Public Open Houses (3)
- Early 2016: Complete Technical Reports
- Mid 2016: Complete Draft By-law
  - Consultation period on Draft By-law (end 2016)
- Early 2017: By-law Preparation
- Mid 2017: Zoning By-law Public Meeting

# **Ticket Allocation & Dignitary Accreditation**

## **Background**

- May 2014 Council approved the Town's "Gold" level Pan Am Municipal Designation
- Other Gold Designated Municipalities
  - > Hamilton
  - Markham
  - > St. Catharines/Welland
  - > Caledon
- As a benefit of designation, the Town will receive 800 complimentary tickets
  - Baseball/Softball (Ajax)
  - Soccer (Hamilton)
  - Opening & Closing Ceremonies
- Council Members are eligible for Dignitary Accreditation





# **Community Ticket Allocation**



## **Community Allocation**

Town responsible for determining the recipients & distribution model



#### **Areas of Focus**

#### **Children & Youth**

- Advances the Town goals related to sport, culture and youth development
- Aligns with TO2015's goal to make the Games "the most youth friendly ever" & the approach of other municipalities

# **Local Sport Associations**

 Recognizes the support & patience of our local sport associations whose schedules and venues have been impacted

# Community Recognition & Giveaways

 Provide avenues for a diverse group of individuals & families to participate in the Games



#### **Recommended Allocation**

60%

Town camps and youth programs

20%

 Community Sports Associations who have been impacted - Baseball/Softball/Soccer

20%

 Community Recognition - community giveaways, host committee members, staff etc.

- Staff will be meeting to begin allocating the tickets & formalizing the implementation plan
- Percentages will be used as a guideline





## **Dignitary Accreditation**



## **Dignitary Accreditation**

- Passes to be shared amongst Council members and guests
  - > Access to Ajax venue & games/ceremonies throughout Pan Am footprint
  - Eliminates need for a physical ticket to enter a venue
- Staff will be responsible for daily management of the passes
- The Mayor & one guest will have full access to games & ceremonies
  - Guest pass is transferable
- Council members can accredit two guests
  - Guests would be eligible to accompany a Council member based on the availability of the pass(es).



#### **Two-Part Pass**



The First Part (**Identity card**) provides personal details and must be worn by the bearer at all times; by itself it does not give access to any venues





The Second Part (**Access card**) is non nominative, provides access entitlements and may be transferred among accredited people

\*Both must be worn together to access a venue
