NWMO REPORT TO THE COMMITTEE

Norman Sandberg introduced the NWMO members who were in attendance along with the Dave Hardy from Hardy Stevenson and Associates. Mr. Sandberg and Tammy Olsen updated all on regional and local meetings, events and presentations. Norman Sandberg also spoke about the NWMO Open Houses that were held in the area during the week of April 24th. He noted that 215 people attended the Elliot Lake Open House at its new venue, the Collins Hall. The number of students attending this year was down but the number of adults attending was like the numbers when the Open Houses were held at the White Mountain building.

Mr. Sandberg spoke briefly about the aerial surveying of the Lake Mazhabong block and the upcoming geological studies of easily reached areas of the block. Also after these studies an environmental baseline will be created by the NWMO specialists and their consultants. A report will be presented in early 2018 to the City on the NWMO's findings.

Dear members of CLC

Location

The Franco-Ontarian Leadership Training Course is an exceptional opportunity for our students to be part of a provincial network of leaders. The internship allows participants to create lasting relationships with their counterparts across the province. They will be able to take advantage of this network over the coming years to continue sharing their accomplishments and challenges, exchange ideas and continue to develop new initiatives at both the local and provincial levels. Participants in our school will receive concrete tools that will support them in organizing activities, teamwork and communication. Upon their return, SFOFEL participants become important resources for our school's students and can support the initiatives of our student council and other school committees. This provincial internship contributes to a student's leadership path and complements the leadership training that a participant has already completed. The internship encourages students to share their knowledge with their peers and encourages them to continue to get involved and give back to their community after high school. With the school support, the participants of the course will receive, on their return, constructive feedback from the animation team. It is recommended that management and a staff member conduct an overview (along with the participant) of the feedback that is sent post-internship. This feedback will support and empower participants in their leadership development by recognizing the skills acquired during the course. In addition, the feedback identifies some avenues for continuing the student's leadership pathway so that the training has a long-term impact.

Number of Visitors
