

Traffic Initiatives

R.I.D.E.

The Wellington County Traffic Unit conducted a total of 14 R.I.D.E initiatives across the County checking 1,311 vehicles, performing 19 roadside tests; resulting in 10 suspensions and 9 drinking and driving charges.

Speed Spy

The Traffic Unit continues to strategically deploy the Speed Spy units in multiple locations across the County based in traffic complaint, collision and high-volume traffic areas. Deployment of the Speed Spy units has been completed in collaboration with Wellington County and Municipal Roads personnel. This partnership has proven very successful as raw data has been shared to assist with understanding the issues. Speed information is analyzed and interpreted by the OPP for a more strategic and intelligent deployment of resources.

Automated Licence Plate Reader (A.L.P.R.)

The strategic deployment of the ALPR Cruiser continues to detect offences in addition to "licence plates in poor standing". During the month of June Wellington County Detachment conducted 163 operating hours in the Automated Licence Plate Reader (ALPR cruiser). Officers laid a total of 54 charges under various Provincial Offence Acts, along with two Over 80 charges, one charge under the Controlled Drugs and Substances Act, seven Warn Range driver's licence suspension and 17 additional roadside breath tests on drivers who had consumed alcohol.

Marine Patrol

The Wellington County Traffic Unit took to the waterways during the month of June logging a total of 48.25 marine patrol hours on area lakes. Marine patrol was also conducted during the Guelph Lake Triathlon.





Auxiliary HESSELINK volunteered five hours and her ability to identify possible Car Seat and other HTA offences was tremendously appreciated. Her proactive approach led to three adult Seatbelt charges being laid, along with two other HTA offences.

On April 6, 2015, both Auxiliary C. KEELER and Auxiliary Sgt D. ELLIS volunteered eight hours each. Auxiliary KEELER was of great help being a Car Seat Inspector and assisted with over 20 inspections. She also worked in tandem with Auxiliary Sgt ELLIS to act as a "spotter" to advise of vehicles to stop. Auxiliary KEELER was seen interacting with the young children and her positive attitude was well noted by the public.

Auxiliary Sgt ELLIS attended with less than 24 hours notice. If she had not attended, we would not have had such fantastic results. She is not a Car Scat Inspector, but played a critical role as a "spotter" which led to five Adult Seatbelt charges being issued.

Without the help of these Auxiliaries, Wellington County OPP could not have conducted this successful campaign. In addition, it should be noted that all four assisted on a holiday weekend and they all attend annual requalification on their own time

By reviewing and correcting 147 car seats, they may have saved a young child from serious injury or death.

On June 3, 2015 a grade 10 student at Centre Wellington District High School was lured off school property during lunch hour by another student to retrieve his previously stolen bicycle.

The student was taken to a remote location where he was confronted by four other students. The victim was then jumped from behind and thrown to the ground, suffering multiple kicks and punches to the body; the student would later require medical attention. During the assault the victims backpack was removed and several personal items, including his wallet, were stolen.

The School Resource Officer, PC SMITH, was tasked by the area Crime Sergeant to lead the investigation. With minimal assistance or supervision by the Wellington County Crime Unit, PC SMITH, identified, interviewed and processed four students for Robbery. At the same time, PC SMITH was able to full fill all of his previously arranged school commitments.



Traffic Initiatives

R.I.D.E.

The Wellington County Traffic Unit conducted a total of 36 R.I.D.E initiatives across the County checking 3,791 vehicles, performing 85 roadside tests; resulting in 28 suspensions and 17 drinking and driving charges.

Speed Spy

The Traffic Unit continues to strategically deploy the Speed Spy units in multiple locations across the County based on traffic complaint, collision and high-volume traffic areas. Deployment of the Speed Spy units has been completed in collaboration with Wellington County and Municipal Roads personnel. This partnership has proven very successful as raw data has been shared to assist to better understanding the issues. Speed information is analyzed and interpreted by the OPP for a more strategic, intelligence-led deployment of resources as necessary.

Automated Licence Plate Reader (A.L.P.R.)

The strategic deployment of the ALPR Cruiser continues to detect offences in addition to "licence plates in poor standing". During the month of July Wellington County Detachment conducted 145 operating hours in the Automated Licence Plate Reader (ALPR cruiser). Officers laid a total of 85 charges under various Provincial Offence Acts including 27 suspended driver charges and 10 other charges under the Compulsory Automobile Insurance Act. Officers in the ALPR Cruiser also laid three Over 80 charges, one Impaired Driving charge, one charge under the Controlled Drugs and Substances Act, two Warn Range driver's licence suspension and 25 additional roadside breath tests.

Marine Patrol

The Wellington County Traffic Unit continued to conduct proactive marine safety patrols on the waterways during the month of July logging a whopping 210.75 hours of marine patrol on area lakes. Marine patrol was also conducted during the Belwood Lake Triathlon and Hillside Festival.

Bicvcle Patrol

The Wellington County Traffic Unit conducted 23.00 hours of bicycle patrol during the month of July.





Date: July 2, 2015 Location: Rockwood

Wellington County OPP responded to a report of an intoxicated male banging on the door of a residence and entering the complainant's vehicle. Upon arrival officers learned that the suspect had been involved in an MVC in which the vehicle had flipped several times and had sustained serious damage. The suspect told officers that there had been two passengers in the vehicle with him at the time of the crash. Canine conducted a search of the surrounding bush and trail with negative results. Investigators located the two passengers and determined that they had separated from the vehicle/driver earlier in the night

Date: July 4, 2015 Location: Morriston

Wellington County OPP responded to a report of an abandoned vehicle located by the owner of a rural property. Investigation revealed that the registered owner of the vehicle was from Hamilton and that he has been missing from his residence since 4:00am. Canine attended the scene and located the vehicle owner in the upper level of an abandoned/boarded up house on the property. The vehicle owner was returned home by officers

Date: July 5, 2015 Location: Goderich

The Canine Unit was requested to assist with locating a wanted male suspect. The suspect was seen in a bush area and he was believed to be armed with a weapon. Canine was cancelled when the suspect was located

Date: July 7, 2015 Location: West Grey

West Grey Police attended a residence after the complainant reported that she would like to revoke the surety on a female party living at the residents. As police were speaking with the complainant the female party jumped from an upstairs window and fled from the residence into the woods. The female party was in Breach of Recognizance by failing to remain inside the residence and West Grey PD was also concerned for her safety as she had made suicidal comments. The Canine Unit was redirected to an area on Grey Road 3 where the female party was spotted running into a bush. After 2.5 hours grid searching the surrounding area without locating the female party or any evidence of her being in the area, Canine was called off and West Grey Police are continuing the investigation

Date: July 10, 2015 Location: Wellington

A patrol officer observed a suspect walking on Queen Street carrying a case of beer. The officer knew the suspect to be bound by release conditions not to possess alcohol. When the officer tried to affect an arrest the suspect fled through a parking lot and jumped over a fence into the wooded ravine along the Grand River. Approximately 10 minutes later, the suspect was spotted exiting the forest about 300m east of the original location and was arrested without further incident. The investigator had information that the suspect is a methamphetamine dealer and due to the circumstances he felt that the suspect may have hidden drugs in the bush. Knox was used to track the suspect from the original location to the point of arrest and Jag was used to search for drugs along the track. Nothing was located

Date: July 14, 2015

Location: Hamilton Wentworth Detention Centre

The Canine Unit was requested to assist with a drug search. Canine attended with CO Newhook and searched Unit 3-B right and the dorm. Jag indicated under toilet in cell 18, located saran wrap with a minor amount of marihuana. No other indications

Bruce Peninsula investigated a shooting incident and formed grounds to believe that the three suspects were inside a residential trailer in Keady. Toronto 2015 Pan Am & Parapan Am Games

The Toronto 2015 Pan Am & Parapan Am Games were held from July 10 to August 15, 2015. The Wellington County OPP assisted with security and law enforcement throughout the entirety of the games. Starting on June 21st, 2015 three trained motorcycle officers were sent to patrol the over 250km of Games Route Network which included the High Occupancy Vehicle lanes that stretched the 400 series highways throughout the Greater Toronto Area. These officers were deployed to the games for the entire event returning to their regular shifts in Wellington County on August 16, 2015.

The main deployment of Wellington County officers occurred from June 27th to August 11, 2015. Wellington County OPP deployed six Sergeants and 32 Constables on various shifts to the games with each of them being assigned to a variety of events and locations across the Pan Am Games footprint.

Wellington County OPP Inspector Scott LAWSON was also deployed to the Toronto 2015 Pan Am & Parapan Am Games as the Operations Chief in the Unified Command Centre. Duties included leading the Command Centre Operations with integrated partners (RCMP, FBI, US State Department, Toronto Police, Environment Canada, Emergency Management, Intelligence, private security, media, planning, logistics, IT and other internal OPP entities) responsible for all operational decisions regarding officer and specialized field resource deployment ie: Public Order, CBRNE, Canine, Explosives and aerial support to ensure the safety of all athletes, spectators and general public.

15th Annual Mount Forest Fireworks Festival

The Mount Forest Fireworks Festival was held on July 17-19, 2015. Wellington County OPP officers attended and performed traffic control and both bike and foot patrol of the event area. In all, 12 uniform officers and one Sergeant attended the weekend event. Sergeant P. HORRIGAN reported no significant policing issues occurred during the event.

Fergus Truck Show

The Fergus Truck Show ran from July 23-26, 2015. There were 25 Wellington County OPP officers deployed at the four day event. Officers performed foot patrol, calls for service and liaised with the public that attended the event. Wellington County OPP officers also provided security for the live concerts that took place each day. No significant policing issues were reported.

Hillside Festival

On the weekend of July 24-26, 2015 Guelph Lake Conservation Area was home once again to the Hillside Festival. Wellington County OPP deployed 12 uniform officers to provide security in a paid duty capacity along with three officers conducting marine patrol and when resources permitted, frontline officers attended to bolster security.

The primary police activities at the festival were marine safety and traffic control, but police were also called to theft investigations, an ambulance assistance call and some minor incidents of overzealous attendees. There were no major incidents to report and Marine patrol issued some Provincial Offence Notices.



Traffic Initiatives

Speed Spy

Using an analytical approach, including traffic complaints from the public and others, deployment of the Speed Spy units continues across the County. Additional officers have been trained based on the increase need and request for their data. Information from the deployments is shared with various Municipalities and Roads Departments to assist with traffic management strategies. Units will be used during the Detachment's September Back to School safety campaign to assist in identifying and developing collaborative safety strategies as required.

Automated Licence Plate Reader (A.L.P.R.)

During the month of August the Wellington County Detachment conducted 90 operating hours in the Automated Licence Plate Reader (ALPR) cruiser. Officers laid a total of 58 charges under various Provincial Offence Acts. Officers laid one Over 80 charges and four additional roadside breath tests. The ALPR cruiser also detected a stolen licence plate, charges where were laid.

Marine Patrol

The Wellington County Traffic Unit continued to conduct proactive marine safety patrols on the waterways during the month of August logging a 96.50 hours of marine patrol on area lakes.


