Across Canada, cities, municipalities and recently Parliamentarians have declared a climate emergency, (see list included). The recent IPCC report warns that we need to have 100 % clean energy by 2030. As Environment Minister Catherine McKenna notes, "climate change is a real and urgent crisis, driven by human activity, marked by extreme weather events". In July this year, the House committed to meeting national emissions targets under the Paris Agreement but Canada is projected to fall far short at its current rate. (see included climateactiontracker.org).

I understand that Stratford is already in the midst of developing a climate action plan and the act of declaring a climate emergency would be a powerful opportunity to include those plans and projects (such as the very important bio digester project), within a climate emergency framework. We urge you to match the aim set by our sister city, Stratford-on-Avon, in the UK, to be carbon neutral by 2030.

Stratford's position as an international tourist destination enables us to exercise a leading influence around the world. Please declare a climate emergency and acknowledge publicly that local governments have a role to play in responding to climate change through their own practices and policies and through leadership and facilitation.

Canadian Framework on Clean Growth and Climate, its overarching strategy for reducing emissions, adopted in 2016; often in the face of provincial pushback. The Government is implementing its coalfired power plant phase-out, but it clearly needs to take more climate action, as emissions are projected to still be above 1990 levels beyond 2030, far from its Paris Agreement target and nowhere near a 1.5°C-compatible pathway.

The federal government had been facing strong headwinds against climate action at the provincial level, with four provinces (Saskatchewan, Manitoba, Ontario, and New Brunswick) challenging the constitutionality of its mandatory federal carbon pricing system. These provinces have no - or insufficient - climate plans and the carbon pricing system applies to them while these court challenges proceed. The first of the cases was recently decided in favour of the federal government and will now be appealed to the highest court in the country, the Supreme Court. The headwinds reached gale force in April with the election of a conservative government in Alberta. The new government has already begun rolling back the province's climate policy, while the federal government has stated that it will apply the federal carbon pricing 'backstop' to Alberta as well.

October 1 - International Day of Older Persons

The General Assembly of the United Nations designated October 1 as the International Day of Older Persons.

By designating a special day in recognition of seniors, the UN is drawing attention to the important contribution of seniors and to changing demographics: the greying of the population, or the "age of aging."

Unifor affirms a commitment to older persons and the essential contributions they make to our communities.

"It's vital to remember that older persons are among the most vulnerable in society and are among the first to fall victim to the effects of a downturn in the economy and to the negative impact of government policies," said Len Hope, Chairperson of the Unifor Retired Workers Council Executive and Unifor Executive Board member.

In Canada, many seniors are living in poverty and do not have adequate housing, care or access to health services. As well, the rate of poverty is particularly high among senior women. We also know that recent changes to Canada's retirement income system are of concern to many Canadians. The increase of the retirement age for the Old Age Security pension from 65 to 67 will start in 2023 and this will hit low income seniors the most. Those who work in physically demanding jobs and those with poor health will no longer have the option to retire at 65.

Meanwhile, those who rely on federally regulated defined benefit pension plans recently discovered that the Federal government plans to introduce legislation to allow for those plans to be changed to the less secure target benefit plans. In a target benefit plan, retiree pension cheques can be cut. Many seniors' organisations have objected, insisting that employers have a responsibility to honour their pension promises. At the same time, they continue to pressure the Federal government to improve retirement security for everyone by expanding the Canada Pension Plan. This is a policy decision that would benefit the next generation of workers the most and have little impact on today's seniors.

In this Federal Election, Unifor will be urging all Federal parties to develop and outline a plan of action that identifies independence, participation, care, self-fulfillment and retirement with dignity as central features of respect for older persons.

The International Day of Older Persons was observed for the first time throughout the world on October 1, 1991.

INTERNATIONAL DAY OF OLDER PERSONS 2019



Celebrated Annually on October 1st – International Day of Older Persons

Resolution 45/106, passed by the United Nations General Assembly on December 14th 1990, declared October 1st to be the International Day of Older Persons. The theme for the 2018 celebration is "Celebrating Older Human Rights champions".

How do People Celebrate?

The day is a special one for older people and senior citizens around the world. You may find officials and politicians making speeches that focus on this growing section of the population, at this time of the year. The media will also take this as an opportunity to publish interviews. Many of which will be with older persons who have had an impact on society. Schools, public institutions and office buildings will also use the day for announcing activities that promote older persons.

The World Health Organisation

The WHO has been playing a significant role in celebrations, and actively promoting public awareness of the day. Discussions have been held relating to the ageing population, providing adequate health provisions, social care and volunteer work.

Various Initiatives Preceded the Resolution

There are currently around 700 million people over the age of 60. It is predicted that by 2050, this figure will have risen to 2 billion. These figures have prompted a lot of attention and various initiatives have been started to try and address the problems that will arise. For example, the Vienna Plan of Action on Ageing which was adopted in 1982. The United Nations Principles for Older Persons was adopted in 1991.
