



2015 Capital Budget and




General Levy Reserve Allocations

- Allocations are integral to the Capital Budget/LRCF; as a result they are now approved at the same time
- Under the FSP, the allocations cannot be changed as part the review and approval of the Operating Budget
- Increase in allocations is funded by:
 - > \$198,000 from 25% of forecasted assessment growth
 - > \$200,000 increase in interest income
- Reduction in allocation to Post Growth Capital Reserve due to lower growth, has been offset by increased interest income
- Total allocation of \$4,892,200 continues to focus on capital, with all but \$60,000 (Election Reserve) going to capital reserves


Spending Cap Guidelines


- Where possible, spending in six main capital reserves should not exceed 65% of the total annual reserve revenues from all sources
- Exceeding cap by 2-3% in a single year is a reasonable tolerance



Slots Revenues

- Assumes existing facility remains in Ajax for next 5 years, at current revenue levels
- 96% of the \$6,817,500 in revenue is allocated to capital reserves

Overdraft – 2013 Dev. Charges

 Caused by timing difference between project cashflows and collection of the DC's from development

Studies:

- Slight overdraft from 2015 through 2017; recovers in 2018/2019
- If necessary, additional funding will come from Development Reserve

Fire & Emergency Services:

- Dates back to 2004 due to purchase of additional fire truck
- DC rules do not allow rate to be increased to recover shortfall
- Any new purchases are being fully funded by Development Reserve

Roads & Related:

- Triggered by Rossland Road project in 2015 through 2016
- Returns to positive in 2017, if development projections met
- If still overdraft, major 2018 & 2019 projects will be delayed;
 (Hunt St. Extension and Church St. Bridge)



Federal Gas Tax Revenues

- New agreement provides significantly more flexibility in allowable uses
- Following chart is a guideline to ensure funds are used effectively in FSP
