# 6.2.1 Heather Weyers

Ms. Weyers advised as a parent she has concerns with the recommendation to move the Huron and Huntingdon crossing. The total number of pedestrians using the crossing and the schools and operations affected by moving the crossing were discussed.

It was noted safety concerns have been identified previously and the development in the area has greatly increased the volume of traffic. Concerns were noted with allowing crossing at Huron and Forman as it is a heavily used intersection, there is not a second sidewalk on part of Forman, there are busy driveways to cross and with Central students going to Northwestern in September there will be increased activity at this intersection.

Support was expressed for options 1, 2, 5, and 6 outlined in the management report titled "Update to the Huron & Huntingdon Crossing". Ms. Weyers requested that the crossing be kept at Huron and Huntingdon and that a signalized intersection be installed. In addition, requests were made to install more signs, utilize social media to bring awareness to issues at crossing locations, provide the crossing guards with flashing stop signs, add speed advisory signs and to continue with police presence at the intersection.

# 6.2.2 Andy Mark

Mr. Mark advised he would like to be included in the discussions around this crossing and wants to be involved in finding a safe solution. Mayor Mathieson was thanked for reaching out to the Ministry of Transportation Ontario.

# 7.2 Report - Update on the Huron Street & Huntingdon Avenue Crossing (COU19-005)

It was questioned how long the traffic counts and studies will take before recommendations can be made. The Director of Infrastructure and Development Services advised it could be 3-4 weeks.

Support was expressed for leaving the crossing at Huron and Huntingdon while the traffic counts and studies are being undertaken. Concern was noted that as safety concerns have been identified the crossing should be moved until final recommendations can be made.

It was suggested the installation of a second sidewalk on Forman should be a priority. Concern was noted with installing a sidewalk before final recommendations on whether the timing of the lights can be changed are made.

Discussion was held on additions that can be made to this area in order to address the safety concerns.

It was questioned how much a signalized intersection will cost. The Director of Infrastructure and Development Services advised it would be more than \$150,000 plus intersection improvements.

It was questioned whether Huntingdon could be closed during the crossing times. The Director of Infrastructure and Development Services advised it could be but that the unintended consequences should be studied. It was noted a transit route uses Huntingdon.

THAT staff request approval from the Ministry of Transportation Ontario to reduce the speed on Huron Street between John and Forman to 40km/hr and to double the fine for speeding along that stretch;

THAT Stratford Police Services be requested to continue to provide a police presence at the Huron/Huntingdon intersection to assist with safe crossings;

AND THAT staff prepare a follow-up report for the February 11, 2019 Regular Council meeting on the Huron & Huntingdon crossing.

#### quarterly basis;

AND WHEREAS pursuant to a Declaration of Sole Shareholder of the Corporation dated January 22, 2001, the prior written consent of the City as the sole shareholder to the declaration and payment of such dividends is necessary;

NOW THEREFORE BE IT RESOLVED that the City hereby consents to the declaration and payment of dividends on the Common shares of the Corporation in the total amount of \$17.00 per share (aggregate amount \$118,915.00) such dividends to be declared payable to the shareholder of record with respect to such shares as of the 30th day of each of March, June, September, and December.

AND WHEREAS, The Corporation of the City of Stratford (the City) is the holder of 6,100 Class A Special shares of Festival Hydro Inc., (the Corporation) being all of the issued and outstanding Class A Special shares of the Corporation;

AND WHEREAS the Directors of the said Corporation have indicated their desire to declare and pay dividends on the Class A Special shares aggregating \$76,250.00 during the 2019 calendar year; such dividends to be declared and paid on a quarterly basis;

AND WHEREAS pursuant to a Declaration of Sole Shareholder of the Corporation dated January 22, 2001, the prior written consent of the City as the sole shareholder to the declaration and payment of such dividends is necessary;

NOW THEREFORE BE IT RESOLVED that the City hereby consents to the declaration and payment of dividends on the Class A Special shares of the Corporation in the total amount of \$12.50 per share (aggregate amount \$76,250.00), such dividends to be declared payable to the shareholder of record with respect to such shares as of the 30th day of each of March, June, September, and December.

This results in total special and common share dividends paid in the year equal \$780,660.
