 - Travel North on Hurontario Street to Burnhamthorpe Road East.
 - Turn east onto Burnhamthorpe Road East, head towards Central Parkway East.
 - Turn south bound on Central Parkway East.
 - Turn west bound onto Mississauga Valley Blvd East.
 - The Community Centre is on the left side.
