That the Minutes of the Leamington Police Services Board Meeting held April 12, 2017 be approved.

Mr. Bill Crangle thanked John Paterson for permitting him to speak at the last meeting. He was informed by Mr. Paterson that he did not have permission to speak at this meeting and requested Mr. Crangle respect the procedures going forward.

Staff Sergeant Bertram noted they are still experiencing challenges when compiling the reports. He further noted there were over 900 calls for service in March, more than 130 of which were 911 hang-ups.

Staff Sergeant Bertram explained there were 119 traffic calls, including three impaired charges in March. Further, there were 47 motor vehicle collisions which resulted in no fatalities.

With respect to the statistics provided, Staff Sergeant Bertram confirmed the violent crimes, property crimes and drug crimes statistics were correct.

Staff Sergeant Bertram informed the Board there were more than 950 calls for service in April. He further informed the Board there were six impaired charges, noting there is a great deal of public participation with identifying drivers who show signs of intoxication.

Staff Sergeant Bertram noted there was an increase in property crimes, including break and enters. He explained a number of them involved unsecured homes and vehicles.

There was a brief discussion regarding 911 hang-ups. In response to an inquiry from the Board, Staff Sergeant Bertram explained a number of them are due to pocket dials or are made by children.

In response to an inquiry from the Board, Staff Sergeant Bertram explained when it comes to billing, calls for service are averaged over four years so if there is a spike in calls the average will be used. He further explained each type of call for service is gauged at a different rate.

Ruth Orton explained the purpose of the grant, noting the Municipality typically receives approximately \$39,000 of a maximum \$60,000 in funding under the program.

Questions and Statement Session:

John Paterson requested an update on the meeting held regarding the youth residence on Sherk Street. Staff Sergeant Bertram explained an Open House was held at Leamington District Secondary School during which residents could attend and ask questions. He noted he initially thought the majority of the comments received would be negative, but in fact they were very positive. Staff Sergeant Bertram further explained how the facility is managed will be a key factor.

John Paterson noted Council approved a temporary youth shelter within the existing building. Ruth Orton further noted the Zoning By-law Amendment allowed for residential uses in connection with an institutional use and that currently overnight stays are not permitted.

Ruth Orton informed the Board that the Committee overseeing the project have conducted a great deal of research on how other similar programs have been run. She noted the facility will be operated outside of the Residential Tenancies Act and if a youth who is staying there breaches their agreement with the facility, they will be asked to leave.

The Board was informed that the applicants hope to construct a residential area in the rear of the property which will allow for thirteen rooms for those requiring longer stays. They were further informed that there are an estimated 100 “couch surfing” youth in the area.

In response to an inquiry from the Board, Sergeant Ribble noted they expect to have data regarding the ongoing problem with vehicles on Erie Street South, Cherry Lane and at the Marina in the near future.

John Paterson noted he received a complaint regarding speeding on Clark Street. Sergeant Ribble will contact the complainant and obtain information.

Staff Sergeant Bertram provided an update regarding Project Safe Trade. He noted the signs were delivered to the Municipality. Ruth Orton confirmed the Public Works department will be installing the signs and information regarding the program will be posted on the Municipality's social media sites.

Staff Sergeant Bertram informed the Board the core unit officers have been making routine drop-ins at the Leamington Lodge and any concerns they see will be reported and passed onto Ms. Orton and the County for follow-up.

Staff Sergeant Bertram noted the Speed Trailer has been purchased and they are awaiting delivery.

Staff Sergeant Bertram noted he has been working with Roberta Jarecsni on the "Not my Kid, Opioids and Adolescents" event to take place that evening at the Kingsville Community Centre. He noted the event is open to the public and is from 6:30 PM to 8:30 PM.

Staff Sergeant Bertram informed the Board that the OPP have been conducting a number of initiatives over the past months, including a Distracted Driving campaign in March. He noted 35 charges were laid throughout the County in one weekend, which is 75% increase over other weekends. He further noted there is a \$490 ticket for being given a distracted driving ticket.

Staff Sergeant Bertram further noted over the Easter weekend over 2090 charges were laid for speeding, distracted driving, impaired driving and seatbelt infractions.

Staff Sergeant Bertram explained they have been facing challenges at the Marina and that rubber speed bumps may be an option to control speeding the parking lot. John Paterson noted he will pass on the idea to the Municipality's engineering department.

John Jacobs inquired whether the OPP are involved in enforcing the new taxi by-law. Ruth Orton noted the OPP have been involved in many enforcement initiatives, including after hours at grocery stores looking for ghost taxis. Ms. Orton further explained licensed drivers are being educated on compliance with the by-law, internal record documents are being requested from the companies and the OPP can request drivers to provide trip records.

Joan McSweeney requested an update on tow trucks. John Paterson noted he has not heard of any complaints in the last while.

John Paterson informed the Board that Council declined a request from local residents to be allowed to “street evangelize”. Ruth Orton noted she will contact them and advise them that a regular speaking voice is acceptable, however anything more than that which may distract motorists will not be permitted.

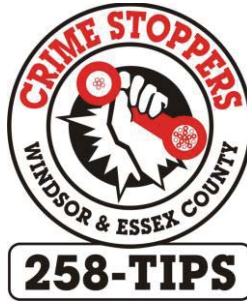

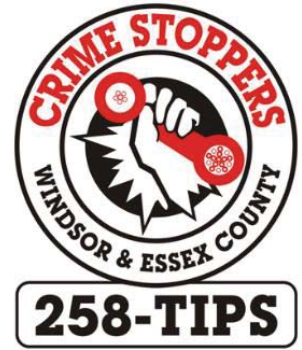
