# 1. <u>S. Cairns, District Accessibility Advisory Committee - Prioritization & Planning of Audible</u> Traffic Signals

Councillor Cairns, Chair of the District's Accessibility Advisory Committee provided Committee with information surrounding the "Prioritization & Planning of Audible Traffic Signals Project" lead by the District Municipality of Muskoka.

Committee requested and received clarifications surrounding legislative requirement/standards, project mandate, task force commitments, public participation, pre-identified priority installations within the Town of Gravenhurst, accessible needs at various types of crossings, District completion timelines, Town Staff involvement and light modernization.

Committee agreed to participate in the project and will discuss formal membership appointment later in the agenda.

#### 2. Appointments - Traffic Audible Signals Working Group
