4.1. Sun Parlour Taxi9 Erie Street South, LearningtonTaxicab Owner Licence - Revocation

Failure to comply with condition #2 of the Taxicab Owner Licence:

"That no Taxicab registered to the Taxicab Owner shall park on any highway. For the purposes of this condition "park" and "highway" shall have the same definition as in the Municipality's Traffic By-law".

Contravention of section 30(b) of Taxicab By-law 63-16:

"Taxicab Owner shall establish and maintain parking spaces and in no case shall such parking spaces be located on municipally owned lands or highways".
