- a) Updates: Spraying for Mosquitoes impact on aquatic and bird life
 - Risks & impacts research (B. Beatty & P. LeMoine)

BE IT RESOLVED THAT procedure be lifted to permit public comments regarding spraying for Mosquitoes - impact on aquatic and bird life.

P. LeMoine noted that he brought the matter to the attention of the Muskoka Watershed Council.

Dr. Chris Brew provided members with a review of her extensive research and statistical information on spraying of mosquitoes and related health effects specifically to compound factors and impacts on mosquitos, adults, children and other species.

Committee received information on long term effects of synthetic and non-synthetic spraying practices, including public discussions, confirmation of governmental authorities, correlation studies, carcinogen relationships to spraying, levels of toxic concentrations, and resistance impacts.

Committee engaged in a lengthy discussion on legal uses, qualifications of sprayers, West Nile virus, government awareness of Round-up, public health involvement, non-toxic spray alternatives (home remedies).

Dr. Brew indicated that she will write a letter to the Gravenhurst Banner and MNRF surrounding education on spraying activities.

K. Orsan will circulate studies from Guelph for contribution to the drafting of the letter to the MNRF.

Dr. Brew also indicated contacting Laurentian University for an academic discussion in engaging graduates to conduct further research on the subject.

Committee requested and received clarifications on Freedom of Information access requests and FIPPA restrictions and process from the Deputy Clerk / Committee Coordinator, and subsequently engaged in a discussion on governance structures on remediation.

d) <u>Updates: Passenger Train Service in Muskoka</u>

Further to Ms. Campbell's request, the Committee indicated a desire to support the proposal to re-introduce the CN Passenger Train Service in Muskoka via correspondence as follows:

The Gravenhurst Environmental Advisory Committee promotes actions which protect the natural resources of our region. The cancellation of the Ontario Northland passenger train in 2012 was a devastating blow to green infrastructure and economic development in Gravenhurst and the North. The passenger train which ran from Union Station to North Bay served commuters, visitors and residents who travelled for work, medical appointments, tourism and family visits. Rail travel provided a way to get cars off of the busy highway. Passengers had the comfort of having washrooms, snack facilities and entertainment options on board.

[&]quot; To Whom It May Concern:

We ask you to consider an equitable passenger rail service. As millions are spent on the Windsor – Montreal corridor, where is the comparable spending on the north? The need for passenger rail is greater now than ever, with an aging demographic, increased severe weather incidents and the need for environmental protection.

Bring back the passenger rail service from Toronto to North Bay!
