Tom Gervais, Police Services Advisor - Zone 6, Operations Unit - External Relations Branch - Public Safety Division, Ministry of Community Safety and Correctional Services

Tom Gervais thanked the Board for having him at the meeting, noting he was in attendance to provide an overview of what he does and how he could be of service to the Board.

Mr. Gervais noted he was one of five Advisors in the Province, who discharge the Ministry's responsibilities and provide information and assistance. He noted he can assist Boards with technical matters, duties under the Act, direct the Board to get legal advice if necessary, deal with occasional personal conflicts and conduct issues, provide training to the Board and operate the Ministry inspection program.

Joan McSweeney inquired whether Mr. Gervais could provide any assistance with speeding up the Provincial Board Appointee process, as one appointment has expired and the other is only temporary. Mr. Gervais provided an overview of the appointment process and suggested that if anyone is aware of a person would like to be appointed they should direct them to the online application.

In response to an inquiry from the Board, Mr. Gervais note a level three background check is required for anyone to be considered for an appointment, after which a recommendation is made to the Ministry for an appointment then if approved, to the Cabinet.

Mr. Bill Crangle arrived at the meeting.

Public Portion of the Meeting:

Election of Vice Chair for the Leamington Police Services Board for 2017

John Paterson inquired if there were any nominations for Vice-Chair.

Joan McSweeney nominated John Jacobs to serve as Vice-Chair for the 2017 calendar year. The nomination was seconded by Lorraine Hodgson and accepted by Mr. Jacobs.

Bill Crangle, Leamington resident, stated he had not requested to be listed as a delegation for the meeting.

Staff Sergeant Bertram reviewed the Commander's Reports for January and February, 2017, noting there were no major issues for January despite the officers being quite busy.

Staff Sergeant Bertram informed the Board the OPP conducted a distracted driving campaign earlier in the year that resulted in a 75% increase in charges, or a total of 35 charges during the 1 week campaign. He noted some areas saw an increase of 360% in charges.

Staff Sergeant Bertram explained a Traffic Management Unit was created in October and since their inception, 1250 traffic tickets have been issued across the County. He further explained there has been a drop in the number of major collisions on Highway 3, perhaps due to the increased visibility of the OPP.

In response to an inquiry from the Board, Staff Sergeant Bertram he does not have statistics on specific age groups that were ticketed for distracted driving, however it appears that they range from young drivers to middle-aged. Staff Sergeant Bertram confirmed he will look into whether the information is available.

Mr. Crangle left the meeting and thanked John Paterson.

Staff Sergeant Bertram suggested anyone who sees someone distracted driving should call 1-888-310-1122 and report the offence.

With respect to the February statistics, Staff Sergeant Bertram explained there was an increase in theft under \$5000, including three or four stolen cell phones and the iPads that were taken from the Leamington District Memorial Hospital. He noted there was an arrest made with respect to the stolen iPads.

Questions and Statement Session:

Joan McSweeney informed the Board she attended the March 29, 2017 Sexual Violence and Youth Symposium held at the Ciociaro Club in Windsor, noting the four presentations were excellent. Ms. McSweeney provided a summary of each of the presentations:

1. The first presentation was made by a Native Canadian from Walpole Island who was sexually assaulted as a child. He explained how the abuse has affected him throughout his life.
2. The father of Rehtaeh Parsons, a youth that was gang-raped at a party and had the video circulated who attempted suicide for six months prior to committing suicide, made a presentation on how he sought help for her daughter but was unable to find it. He talks to school boards in an effort to have physical education re-introduced with a focus on anatomy, healthy relationships and consent.
3. A social worker who works with Legal Assistance Windsor provided a presentation on immigration and human trafficking.
4. A Sexual Misconduct Response and Prevention Officer from the University of Windsor talked about the brain, how it functions and what happens following a sexual assault.

Ms. McSweeney suggested the only thing missing from the symposium was a discussion on how to reduce sexual assault, and what is going to be done to remedy this.

Staff Sergeant Bertram explained the symposium was made possible in part with grant funding provided by the Ministry of Public Safety and Correctional Services. As a follow-up, the Leamington CSO is obtaining a presentation on this subject that will be made to all schools in Essex County.

There was a brief discussion regarding ATVs and it was noted there have been some travelling on the beach to the west of Seacliff Park. Staff Sergeant Bertram confirmed officers will be utilizing ATVs once again now that the weather has improved.

John Paterson noted he has been forwarding emails and Facebook posts regarding speeding vehicles on Cherry Lane to the OPP. Staff Sergeant Bertram requested he continue doing so and noted administrative staff have been distributing the information to officers and there have been increased patrols in the area.

John Paterson informed the Board that he has forwarded an email to Staff Sergeant Bertram regarding significant drug activity at a local low-income housing complex. Sergeant Ribble noted officers can conduct bike patrols in that area in an attempt to deter criminal activity.

John Paterson noted administration has met with the County CAO and Treasurer to discuss ongoing issues at the Leamington Lodge. He further noted the Municipality provided a large amount of interesting information regarding the Leamington Lodge to the County. Joan McSweeney suggested that perhaps drop-in inspections could be conducted at the facility. Staff Sergeant Bertram explained the facility is only required to provide a roof, meals and cleaning to those who live there. He further explained that since 2011 the OPP have responded to over 800 calls for service to that address, including to provide assistance to EMS for Fire Services who have concerns about personal or equipment safety. Staff Sergeant Bertram noted there will be regular, unscheduled walk-throughs by the OPP. Ruth Orton informed the Board that the mandate for the facility is to eliminate homelessness and that there is a need for this type of service in the community.

There was a brief discussion regarding the youth drop in centre that has been proposed for Sherk Street and the application regarding possible residences on that site. Staff Sergeant Bertram noted he will be voicing the concerns of the OPP at meetings on the property.

Staff Sergeant Bertram informed the Board the OPP have realigned the services in Leamington in order to bolster the Street Crimes Unit to six officers. He noted the Detective Sergeant for this unit does not have an office in Leamington and they are attempting to repurpose available office space that has been identified in order to accommodate the officer. Staff Sergeant Bertram explained the cost to retrofit the area to create an office will be approximately \$1,017 and requested the Board consider funding this work.

Ruth Orton noted the lease agreement with the OPP for the facility stipulates that any leasehold improvements are the responsibility of the tenant.

Staff Sergeant Bertram noted since the creation of the Street Crimes Unit there has been an increase in calls for service but a 42% decrease in violent crimes since last year.

He further explained there are two options: a box and a sign, and they prefer the sign as it will provide the ability to warn drivers of detours and other traffic concerns.

Sergeant Ribble requested that he and Staff Sergeant Bertram be advised of any speeding complaints they receive.

Role of the Community Safety Officer:
