

Email from Brian Sweet to me (June 12 – 2013) Quote – anytime you are not satisfied with responses from the Municipal Staff you can register as a delegation and come to council.

Goodreau Excavating cleaned out a road ditch between the Coulson Bridge and Paul Schmink and cleaned out a road ditch from Martin Tiessen to the Gillanders drain. — The Excavator left the mess on Mersea Rd. 1 and on Jema Foods Driveway.

I asked Lu ann Barretto — what about the clean up on the Road and the Jema driveway – she stated to me there was no more money in the budget for the clean up. My question to you our Council and Bill Marck — Is clean up not included the contract ?

At a prior council meeting I presented this same issue regarding the manure applicator from Seacliffe Energy and Tiessen Acres to the incorporation sites. — Councilor Hilda Mac Donald stated the Municipality had rules in place for this. — Councillor Verbeke raised the objection to the defense of the Farmers — Council agreed a letter should be sent. — I also emailed Bill Marck to send me a copy of the letter from Council . This letter would show proof and cause for the Bylaw — I never received that copy.

Council — this is how it started that day . Goodreau was contracted by the Municipality to render Ditch work and never provided a clean up and the bylaw was never enforced . — The mess was left beside me. The mess is ALWAYS left beside me.

Quote : By-law 772-02 – Prohibitions – 3 ... No Person shall deposit or permit or cause to be deposited any litter on any highway in the municipality.

Quote: By-law 622-05 – 2.07 (Parking Areas, Walks and Driveways) ... all areas used for vehicular traffic and parking shall have a surface covering of asphalt, concrete or compacted stone or gravel and shall be kept in good repair free of dirt and litter.

Quote: Mr. Bill Marck's email to me — it's on Private property — we can't do anything about it. —

Quote: Joe Isley to Luann Barretto — who gave Goodreau the permission to unload the excavator on Jema's property if it is private property — Quote Luann : we didn't think Jema was operational at this time. I now ask Council — That gives you the right and Trespass or did Jema give permission — also a Tractor trailer pulled in. — Goodreau's Tandem Axle Truck had to back up the driveway to give the Tractor Trailer access to the factory. — Again I asked Lu ann – who's driveway did Goodreau use when they cleaned out in front of Tiessen Acres — no ones driveway — they used the road and left debris there.

Council — this is just one not one incident - it happened on Mersea Rd. 1 with Rivards (March 07 – 2013) I sent notice to Paul Sharon. — it happened again June 03 – 2013 at Marten's Greenhouses when they spread their greenhouse waste — the road was covered.

I will also let Council know I drive a Public service vehicle with someones child on Board and I'm not going to negotiate the highway and put someones child at risk. — it's not my job to inform the board of works — It's the Municipality's to enforce their own by – laws.

My Recommendation — Address the Bylaw on everyone's Tax Notice — it will be their responsibility to notify the Municipality for clean up — then Bill them.

In Closing I want to remind Council — Your decision is either going to support Bill Mark (CAO) or Joe Isley - I believe the Bylaw supports me. — I also want to quote Council Conduct — Members of Council shall serve and be seen to serve their Constituents in a conscientious and diligent manner.
