- a) THAT staff be authorized to amend waste collection contract (RFI-503-2006) for collection services in the City of Pickering and the Town of Ajax to change the existing residential curbside collection of scrap metal goods to a call-in service and add porcelain bathroom fixtures and waste electrical and electronic equipment to the call-in service for the two municipalities at an estimated net cost in 2012 of approximately \$23,000 to be accommodated within the approved 2012 property tax guideline;
- THAT The Regional Municipality of Durham's existing two item limit for the collection of scrap metal goods be eliminated in all local municipalities in order to increase waste diversion;
- THAT By-law No. 46-2011 be amended to reflect the recommendations of Report No. 2011-WR-15 of the Commissioner of Works; and
- d) THAT a copy of Report No. 2011-WR-15 be distributed to the local area municipalities for information."

#### **RECOMMENDATIONS:**

THAT in order to accommodate the approved waste electrical and electronic equipment and porcelain recycling pilot collection programs, and ensure standardized waste collection services Region-wide, the Works Committee, subject to the approval of the Finance and Administration Committee (recommendations a and b), recommends to Regional Council that:

- a) Staff be authorized to amend waste collection contract (RFI-503-2006) for collection services in the City of Pickering and the Town of Ajax to change the existing residential curbside collection of scrap metal goods to a call-in service and add porcelain bathroom fixtures and waste electrical and electronic equipment to the call-in service for the two municipalities at an estimated net cost in 2012 of approximately \$23,000 to be accommodated within the approved 2012 property tax guideline;
- b) The Regional Municipality of Durham's existing two item limit for the collection of scrap metal goods be eliminated in all local municipalities in order to increase waste diversion;
- c) By-law 46-2011 be amended to reflect the recommendations of this report; and,

#### 1. PURPOSE

This report recommends changing the existing residential curbside collection of scrap metal goods in the Town of Ajax (Ajax) and the City of Pickering (Pickering) to a call-in service, and adding waste electrical and electronic equipment (WEEE) and porcelain bathroom fixtures to that collection.

It is also recommended that the Regional Municipality of Durham's (Region's) two item limit for collection of scrap metal goods be eliminated Region-wide to increase waste diversion and decrease program costs.

#### 2. BACKGROUND

At its meeting of February 24, 2011, Regional Council approved Works and Finance and Administration Committee report 2011-J-22 authorizing staff to enter into a partnership agreement with the Provincial Government's Ontario Electronic Stewardship (OES) to develop and execute a pilot project to test the curbside collection of WEEE, provided there is no additional net costs to the Region.

At its meeting of June 15, 2011, Regional Council approved Works Committee report 2011-WR-9 (Attachment No. 1) authorizing a pilot project to test the curbside collection of porcelain fixtures throughout the Region and for staff to negotiate the necessary contractual and operational changes required to support the pilot project with the collection contractor.

On August 15, 2011, Regional staff met with the collection contractor, Miller Waste Systems (Miller) to discuss the proposed service changes. Miller has confirmed in writing (Attachment No. 2), that it can accommodate the changes, including a scrap metal goods call-in service in Ajax and Pickering and the addition of WEEE and porcelain fixtures to that service, with no pricing changes.

#### 3. DISCUSSION

Works Committee report 2011-WR-9 (Attachment No. 2) approved the addition of porcelain bathroom fixtures to the Municipality of Clarington and the Townships of Brock, Scugog and Uxbridge call-in scrap metal goods collection service. Once implemented, this service expansion will minimize impacts to existing curbside collection operations and add tonnage to the existing collection operation which had excess collection capacity.

Staff is delaying the curbside collection of porcelain in the Municipality of Clarington and the Townships of Brock, Scugog and Uxbridge until it is also approved in the Town of Ajax and the City of Pickering, so that the curbside collection of porcelain can be launched across the Region simultaneously.

WEEE collection in Clarington, Brock, Scugog and Uxbridge will be accommodated, consistent with the recommendations for Ajax and Pickering,

within the existing collection contract scrap metal goods service and at the existing scrap metal goods per tonne collection rate, with collection costs offset by avoided disposal costs and provincial funding for WEEE.

Staff recommends amending contract RFI-503-2006 to add porcelain bathroom fixtures and WEEE to the scrap metal goods collection in Ajax and Pickering and conversion of the current scrap metal goods collection service to a call-in service. This approach will increase collection efficiencies and will increase diversion for the Region by making materials less available to scavengers.

Currently, scrap metal goods in Ajax and Pickering are collected every other week, on the same day as residual garbage. Residents set out their scrap metal goods with their garbage and the garbage collection crews report any scrap metal goods set-outs to central dispatch who calls a roving cube van to collect the items. This collection is inefficient and reduces diversion because, by having residents set their scrap metal goods out with their regularly scheduled residual waste collection, it makes scrap metal goods readily available to scavengers.

Table 1 summarizes the proposed service changes:

The Region provides only Blue Box collection services in Oshawa and Whitby. Oshawa and Whitby provide the rest of the waste collection services in their respective municipalities. Regional staff will coordinate with the City of Oshawa and Town of Whitby to ensure that their scrap metal goods, porcelain and WEEE collection programs are consistent with the other local area municipalities.

#### 4. PROMOTION AND EDUCATION

Initiatives that will be used to educate the public and promote these new programs and service level adjustments will include use of internet, newspaper, television, radio, public service announcements, and any other means available to the Region.

The communication program will also include a stickering campaign whereby any porcelain, WEEE or scrap metal goods items set out for garbage collection will not be collected as garbage and instead will be stickered with a notice to residents reminding them that the items are recyclable and to make an appointment for their recycling collection.

#### 5. FINANCIAL IMPLICATIONS

Porcelain bathroom fixtures and WEEE will be added to the existing scrap metal goods collection service for the Town of Ajax and the City of Pickering and the scrap metal goods collection in these municipalities will be converted to a call-in service. These changes will be funded within the 2012 Solid Waste Management Business Plan and Budget within the approved property tax guideline, at an annual estimated net cost to the Region of \$23,000, as demonstrated in Table 2. The table includes a breakdown of the estimated net cost and the associated increased tonnes anticipated to be diverted. The status and available results of the pilots will be updated within the annual Solid Waste Management Servicing and Financing Study.

The estimated tonnages in Table 2 are in addition to those projected in Works Committee report 2011-WR-9 (Attachment No. 2).

#### 6. CONCLUSION

Upon approval of this report, the Regional Municipality of Durham will implement a standardized call-in service for the residential curbside collection of scrap metal goods, pilot porcelain collection and recycling, and a curbside pilot for WEEE across the Regional Municipality of Durham, subject to implementation in the City of Oshawa and the Town of Whitby, who will coordinate respective services within their own collection jurisdiction. Regional staff will work closely with the City of Oshawa and Town of Whitby to assist with the implementation of these collection programs in those local area municipalities.

To ensure maximum participation by residents, Regional Waste Management Services staff will develop a communication strategy, along with a change to the Waste Management By-law, to inform residents of the new services and the change to a call-in service.

#### **RECOMMENDATIONS:**

THAT subject to the approval of the Finance and Administration Committee (recommendations a, b, c and e), the Works Committee recommends to Regional Council that:

- a) Approval be given for the implementation of a porcelain collection and recycling pilot program in the Regional Municipality of Durham;
- A Request for Quotations be authorized for the haulage and processing of porcelain fixtures (sinks, toilets, tubs, etc.);
- The implementation of the proposed porcelain collection and recycling pilot program be funded through the 2011 Waste Management Operating Budget;
- The Regional Municipality of Durham coordinate with the City of Oshawa and the Town of Whitby to ensure that porcelain fixtures collected in these Municipalities are also recycled;
- e) The Finance Department be authorized to execute the contract for haulage and processing and negotiate any necessary amendments to existing collection contracts; and
- f) A copy of this report be distributed to the Area Municipalities for their information.

#### REPORT:

#### 1. PURPOSE

This report proposes a Porcelain Collection and Recycling Pilot Program (PRP) for the Regional Municipality of Durham (Region).

#### 2. BACKGROUND

There are currently no options for Regional residents to recycle porcelain fixtures (sinks, toilets, tubs, etc.). These items are classified as home renovation materials in the Region's existing collection contracts and are, therefore, not collected at all for disposal or recycling by the Region. The City of Oshawa and the Town of Whitby currently collects porcelain fixtures through their curbside residual waste operations. The only disposal options for residents outside the City of Oshawa and the Town of Whitby include delivery to the Region's Waste Management Facilities, delivery to private waste management facilities, or hiring a private collection service. All of the options listed above result in the landfill disposal of porcelain fixtures.

As residents modernize their older homes and update to low flush toilets and modern sinks, there is an increasing demand for the Region to include porcelain fixtures in its curbside collection program. In 2010, the Region's Waste Management Call Centre received over 800 inquires regarding toilet disposal.

Staff has investigated recycling opportunities for porcelain fixtures as part of the 70 per cent diversion target to create additional incentives for residents to conveniently divert materials from landfill and has determined that a viable local porcelain recycling market with good potential to meet the Region's needs does exist. Porcelain items are crushed, and metal and plastic parts are removed. The remaining porcelain aggregate material is then used as a substitute to gravel as a porous drainage material, road base material, added into asphalt for paving roads, and has also been used elsewhere in foundation building, trail pavement, mulch or artificial reefs.

#### 3. DISCUSSION

If approved, the proposed PRP pilot will add the collection of porcelain fixtures to the Region's existing residential curbside collection program. Staff estimates the program could collect 390 tonnes of material through a curbside collection program and an additional 125 tonnes through the Region's Waste Management Facilities for a total of 515 tonnes annually.

The PRP pilot program proposes that the porcelain fixtures will be collected using the existing bulky goods collection program and delivered to the Region's Waste Management Facilities where they will be segregated for delivery to the porcelain recycling market.

Porcelain fixtures received directly at the Region's Waste Management Facilities will also be segregated for delivery to the porcelain recycling market.

Staff will work with the Town of Whitby and the City of Oshawa staff to ensure that porcelain fixtures collected by those Area Municipalities are also recycled through the PRP.

Diverting porcelain fixtures is consistent with the Region's 70 per cent waste diversion plan.

#### 4. PROMOTION AND EDUCATION

Initiatives used to educate the public and promote the PRP pilot will include newspaper, television and radio advertisements, public services announcements, waste management calendars, postings on the Region's website and any other means available to the Region.

#### 5. FINANCIAL IMPLICATIONS

The implementation of the proposed porcelain collection and recycling pilot program will be funded from the 2011 Waste Management Operating Budget.

#### 6. CONCLUSION

Upon authorization from Regional Council, Waste Management staff will implement a Porcelain Collection and Recycling Pilot Program and issue a Request for Quotations for the haulage and processing of the porcelain fixtures. Staff will also work with the City of Oshawa and the Town of Whitby to ensure that the porcelain fixtures collected in those municipalities, currently disposed of, are recycled in the Region's porcelain recycling pilot program.

Diverting porcelain fixtures is consistent with the Regional Municipality of Durham's 70 per cent waste diversion plan.

## CONSERVATION AUTHORITIES STRONGLY SUPPORT CALL TO PROTECT ONTARIO'S IMPORTANT BIODIVERSITY

NEWMARKET (January 10, 2012) Conservation Authorities strongly support Ontario's Environmental Commissioner's latest report calling for an integrated provincial approach to protect Ontario's important biodiversity. Conservation Authorities help provincial ministries to achieve their environmental objectives by working together. "We regularly collaborate with the Ministries of Environment, Natural Resources and Agriculture, Food and Rural Affairs because we are closely connected with local communities and ecosystems," Pearson said. "But, as Mr. Miller points out, that work has to continue to be supported because it's not easy managing the significant and growing impact of Ontario's population."

Conservation Authority programs improve water quality, promote water conservation, and protect important local natural areas and habitats, and generally ensure the resilience and sustainability of these resources into the future.

Specifically, Conservation Authorities:

- work in partnership with the Ministry of Environment to deliver the Ontario Drinking Water Source Protection Program and the Ontario Drinking Water Stewardship Program,
- deliver important stewardship and water quality improvement programs that contribute to the implementation of the bi-national Great Lakes Biodiversity Conservation Plans, and
- facilitate watershed planning with municipalities, residents and other agencies.

Native species and ecosystems connect important land and water resources and contribute significantly to the health of people, economy and environment. Healthy biodiversity is key in adapting to climate change and ensures clean drinking water, fresh air and economic benefits.

Nature provides us with many important things that are important to our economy and to our health:

- trees help to clean the air we breathe, improve water quality and regulate our climate;
- wetlands filter drinking water sources, and protect us against flooding and drought, preventing millions of dollars in damages;
- wild plants provide food for us, prevent erosion and help to maintain healthy soil for agricultural crops;
- bees and other insects pollinate crops and wild plants;
- the Great Lakes provide billions of dollars in revenue from activities such as commercial and sport fishing, tourism, recreational boating, beaches, and as a source of drinking water for millions of Ontarians:
- lakes, rivers and natural areas provide popular outdoor recreation and businesses such as snowmobiling, hiking, canoeing, camping, and skiing.

Conservation Ontario continues to participate in the Ontario Biodiversity Council responsible for Ontario's current Biodiversity Strategy.

#### **BACKGROUND:**

Approximately 350 municipal trees are removed annually by Operations and Environmental Services due to mortality, weak structure and accidents. These removals occur within our parks, green spaces and municipal road allowances. Stumps larger than 15 cm in diameter are removed by a mechanical stump grinder. This contracted service is carried out for the following reasons:

- to provide space to accommodate new plantings
- to reduce potential liability e.g., equipment damage and trip hazards
- to reduce maintenance costs

The removal of stumps is scheduled twice annually, in the spring and fall.

#### **COMMUNICATION ISSUES:**

Prior to the municipal tree removal, staff communicate to the resident of the tree removal. Written notification is also provided to neighbouring residents and the tree is marked with orange flagging tape. The resident or customer are also notified of the stump removal process by Town Staff. Contractors are required to knock on each resident's door just prior to commencing work.

#### **CONCLUSION:**

Staff awarded the Contract for the service of removal of stumps to Alineutility Ltd., during Council's recess period, all in accordance with the Town's Purchasing By-Law.





#### **Regional Councillor Report**

#### Works Committee - Jan. 11, 2011

#### Lawrie Road Storage Tank

Works Committee approved additional engineering and construction costs for the storage tank to mitigate basement flooding on Lawrie Road. During the detailed design work it was found that existing utilities were too close to allow for the tank shape as originally proposed. A pump system has had to be incorporated into the design which has increased the construction costs for the tank. The work will proceed as planned in 2012. The Town will work with the Region to host a public information session early in February.

# Class EA to Address Capacity Limitations of Existing Outfall/Diffuser at the Duffin Creek Water Pollution Control Plant

Funding (\$690,466) was approved to retain CH2M Hill Canada for engineering services for Stage 2 of the Class EA regarding the capacity limitations of the outfall/diffuser at Duffins Creek WPCP. Approval was also granted for a peer review of the technical documentation (\$167,608) as well as an allowance (\$100,000) to complete any required contingency investigations identified as part of the peer review process. As York and Durham are co-owners these costs are shared on an equal basis.

The peer review team consists of various consultants led by Craig Mather former CAO of the Toronto Region Conservation Authority. Questions were raised regarding Dr. Martin Auer's peer review of the water quality monitoring of the Ajax/Pickering nearshore waters conducted from 2007 to 2009 by the Toronto Region Conservation Authority for the Regions of York and Durham. In that review Dr. Auer, Professor of Civil and Environmental Engineering at Michigan Technological University concluded the Duffin Creek WPCP was the overwhelming source of phosphorous feeding the cladophora along the Ajax shoreline and that unresolved issues relating to the modeling efforts by the Waterloo University group limit the degree to which conclusions may be drawn regarding the phosphorous provenance issue. Dr. Auer recommended that further work is required to integrate the findings of his peer review with a revised monitoring program to determine the true impact of the various sources of phosphorous on cladophora growth along the Ajax/Pickering nearshore. It has yet to be determined if further study as recommended by Dr. Auer and proposed by Dr. Howell of the Ministry of the Environment would be completed and inform the Environmental Assessment.

#### Joint Committee Meeting – Jan. 12, 2012

The 2012 – 2014 Economic Development Investment Attraction Plan was endorsed by the Committee as part and subject to the 2012 Business Plan and Budget deliberations. The report recommended enhancements to create conditions conducive to investment and job creation. It focused on six priority areas to be implemented over the next three years;

- Focusing on Foreign Direct Investment Attraction
- Renewing Marketing Collateral
- Launching a Targeted Advertising Campaign
- Participating in Business Development Missions
- Restructuring the Division for effective service delivery

The projected annual expenditures for 2012, 2013 and 2014 are expected to come at a total cost of \$1,309,000. For 2012, it is estimated to be \$434,000.00 which includes consulting fees for the Branding Strategy and Foreign Direct Investment Strategy as well as the marketing collateral (design and print) backed by the rebranding strategy. The current branding has been viewed as outdated and doing more damage than good. The Foreign Direct Investment Strategy and Workplan to be coordinated with the Greater Toronto Marketing Assoc. would have independent initiatives designed to attract new investment to Durham. In 2012, the restructuring of the economic division would include a new position, Manager Investment Attraction which would focus on bringing Foreign Direct Investment and other investment to Durham. A revised position of Manager Strategic Initiatives would focus on developing alliances, building partnerships and creating strategic initiatives that support investment in the Region.
