

Traffic Initiatives

Snowmobile Patrols

February saw an increase in snow and the trails were open. County of Wellington OPP officers were on snowmobile patrol. A special RIDE checkpoint was conducted at Wellington Road 10 and Selinger Road in Mapleton at the trail location there. 72 snowmobile operators were checked. With 11 receiving warnings for various infraction. During the patrols in excess of 300 sleds were checked for the month.

RIDE Initiative / Safety Video Production

The County of Wellington OPP participated in a large RIDE / Safety Video Shoot on February 21st. The OPP Command Post was on scene in support of the initiative that was conducted in the area of Highway 6 south of Fergus. 850 vehicles were checked by police. Two of our traffic unit members are now movie stars.

52 other RIDE initiatives were conducted in the County during the month of February.

Operation Starburst

The northern areas of Wellington County were saturated with TMU members every Wednesday during the month of February. Traffic Management Unit members overlapped their shifts to conduct concentrated enforcement in these areas to alleviate traffic concerns.

Road Safety Awareness Initiative

The County of Wellington Roads Department and the OPP have been participating in meetings to develop and implement educational road safety signage throughout the County.



Notable School Related Incidents and Events

Centre Wellington - Meeting with school administration regarding concerns over snowmobile use by students attending school. Legal requirements such as drivers licence, insurance, validation, and trail pass explained. It was determined that the students would be allowed to bring their snowmobiles to school.

Centre Wellington – 24 Criminal Record Checks completed for Co-op Students.

Centre Wellington – The CWDHS girls hockey team, coached by PC Smith, competed twice in February, winning the quarter final game 2-0 against GCVI but coming up short in the semi-final game against CCVI 2-0.

Centre Wellington - Fight in the cafeteria between 2 girls stemming from comments made on Twitter. Resolved by way of school suspension.

Centre Wellington - Bullying incident resulted in 5 grade 10 students receiving Extra-judicial Measures (diversion) to John Howard Society. No physical injuries.

Centre Wellington - Student operating a snowmobile at school was cautioned for not being in compliance with the requirements of insurance, validation, and trail permit. A parent was contacted, attended, and the snowmobile was take home on a trailer.

Centre Wellington – The wooded area across from CWDHS continues to be a problem area for drug use. Enforcement in the area is proving problematic due to accessibility by and high visibility of approaching officers by the suspects.

Erin – School Resource Officer attended the joint Youth Probation & Parole meeting in Guelph between Probation & Parole, Guelph Police youth officers and County of Wellington OPP.

Erin – PC Schubert is an assistant coach with the EDHS boys hockey team. The team competed in two games during this period.

Erin – A student was suspended for fighting and subsequently returned to school the following day and fought a different student. The behavior is uncommon for this student and as a result a threat assessment was conducted involving family, friends, and the school, along with mental health and social agency partners. It was discovered that the original fight was caught on video and posted on the internet via social media. This compounded the subject student's emotional crisis. The persons involved with posting video on the internet were identified and contacted. As a result the videos were removed from internet sources and original phone that was used to record the event. A plan was formed to re-integrate the at risk youth back into school.

Erin - Collaborative work between Police, School administration and Arena Management led to the arrest of 2 youths caught smoking marijuana on camera. Both youths diverted and suspended.

Norwell – The Norwell SRO provided an in depth drug presentation to staff regarding the current trends in the area drug culture. Popular drugs, future trends, drug programs, possibility of a streamlined "drug court" were presented and discussed. The event culminated with a lengthy discussion on the many issues and related topics.

Norwell – PC Clements has been a coach for the Norwell wrestling team for the past three years. The ongoing boycott of extra-curricular activities and other staff related employment issues has proved challenging to the Norwell Wrestling Team. One student placed second at the District Competition in Guelph, however failed to qualify for OFFSA at the CWOSSA tourney held in Cambridge. Wellington County is hosting 2013 OFFSA Wrestling Championships in Guelph on

the 6th and 7th of March at the Sleeman Centre. The event is expected to attract hundreds of high level athletes.

Norwell – The SRO investigated an allegation of child abuse involving three students of Palmerston Public School, along with the excellent assistance of Family and Children's Services. Preventative measures were taken to ensure the safety of the children and FCS continues to work toward a resolution and assist the family at this difficult time.

Wellington Heights – SRO attended the kick off event for the Read a Thon at St. Mary's Catholic School, Mount Forest and read to the Grade 6 Class.

Wellington Heights – SRO assist the Co-Op class preparing criminal record checks and documents needed for employment.

Wellington Heights – PC Watt attended the Youth Conference in Niagara Falls.

Wellington Heights – Proactive patrols are being conducted at two identified residential areas in Mount Forest where known drug activity is taking place during school hours involving youth. Information obtained as a result is being forwarded to the appropriate units and agencies.

Wellington Heights – After the untimely death of a recent graduate of Wellington Heights, PC Watt assisted with crisis intervention, memorial set up, student monitoring and assistance, as well as attendance at the funeral for student support and assistance with grief.

Wellington Heights - In one of several incidents this period two male students were involved in consensual fight when a third male jumped in and kicked one of the males in head. The event was captured on surveillance tape and charges were laid.

Wellington Heights – A report of sexual assault was received from Norwell District Secondary School. The incident had occurred outside of Wellington County. The SRO took investigative steps to assist the outside police agencies and the victim in this matter.

Wellington Heights – A number of threatening type incidents were investigated during this period. These include three incidents of text message threats with one originating from Victoria Cross Public School, a threat via Facebook between two males, and threats made to an adult student by a parent.

Palmerston Public School – CSO/Media Officer Gary Barnhardt provided three separate presentations to students at the Palmerston Public School in relation to Internet Safety, Responsible Technology Use, and Cyber Bullying.

Project Lifesaver

Victim Services in coordination with the Wellington County Ontario Provincial Police (OPP) and the Guelph Police Service (GPS) would like to remind the residents of Wellington County about Project Lifesaver. This program is dedicated to assisting caregivers with finding their loved ones that have wandered off due to suffering from Alzheimer's, Autism, and other forms of cognitive impairment.

Every participant wears a bracelet that is a battery operated wrist transmitter that emits a unique radio frequency every second, twenty-four hours a day. How Project Lifesaver works is that a caregiver notifies Wellington County OPP when a loved one has gone missing and specially trained police officers will use portable directional equipment to search for and locate the missing person.

Wellington County OPP has12 search specialists trained with 2 trainers. Each year those members of the OPP receive their recertification through daylong classroom and practical scenario training.

Cooperative Efforts Between Front-Line and Specialized Unit Protects Community

Several members of the County of Wellington OPP have been recognized by their peers for some excellent policing and team work. The County of Wellington OPP Street Crime Unit and three uniform members from the Mount Forest operation centre worked in conjunction to solve a nd arrest an subject for a number of break and enters that occurred between December 2012 and February 2013. Many of these break and enters were to small businesses and schools in the north Wellington area of our County. As a result the Street Crime Unit focused their investigative efforts in the Town of Mount Forest and the surrounding area. Shifts were altered so there was an investigation focused police presence in that area for 20 hours of the day. Members of the unit

worked in conjunction with Constables Yantzi, Hastings and Mullan who assisted in the identification of suspect, conducting countless vehicle stops and street checks in an effort to solve the crimes. Armed with the information gleaned and further confidential source information, police were able to build a strong circumstantial case against a Mount Forest area man.

As a result of the outstanding efforts of these officers, on February 23rd 2013, the male was arrested for break, enter and theft admitting to 15 break and enter occurrences across Wellington and Grey Counties.

OPP to launch Safeguard program by Kris Svela

Wellington County OPP officials are launching a new initiative in a bid to prevent home and business break-ins, says Inspector Scott Lawson.

He discussed the program with about 40 people attending the mayor's breakfast hosted by Wellington North's Ray Tout on Feb. 21 at the Arthur community centre.

The OPP are in the process of putting together a victim response program known as Safeguard Ontario. The program is designed to address steps residents and business owners can take to prevent break-ins and thefts.

Lawson said the OPP dealt with 518 mischief calls, 266 break-ins and 824 thefts last year. More recently, OPP officers have been canvassing businesses in Mount Forest to talk about a rash of recent break-ins and thefts that in that community.

Lawson said police have been chasing down leads and hope to be narrowing the search for the perpetrators.

"This becomes a real problem," the inspector said, adding potential break-ins and thefts can be reduced if homeowners and business owners, "take that extra minute to lock your home, car, businesses and driving shed."

Lawson was named Wellington OPP Commander in September after 26 years of police experience, including an eight-year tour as a constable at the Mount Forest detachment.

The Safeguard program is similar to one operating in Caledon and Lawson said police there are assisting in the training of eight to 10 Wellington OPP auxiliary officers.

Using auxiliary officers will give the program greater flexibility in that officers can meet with victims at mutually suitable times to discuss ways to prevent future break-ins and thefts. It also leaves frontline officers to conduct regular duties, Lawson added.

The auxiliary officers will inspecting premises and the home or business owners will later receive a report from police about steps that can be taken.

"If we could take three per cent of that (break-ins and thefts) and reduce it we'd be ahead of the game," Lawson said. "It's just a crime of opportunity; quick and dirty, in and out, and they're gone."



Officer honoured

During the breakfast, the inspector presented Tout with a plaque commemorating OPP Constable Rick Hopkins, who gave his life in the line of duty responding to a call in Arthur in 1982.

The constable was honoured at a ceremony in Mount Forest in October, during which a structure on Highway 6 was renamed Cst. Rick Hopkins Memorial Bridge.

Tout noted the plaque will be prominently displayed to honour the officer.

"We will certainly hang this in our municipal office as a reminder of what can happen even in a small community and hopefully won't happen again," the mayor said.



False alarms

The inspector also raised concerns about the number of "911 hang-ups" received by the OPP, a large portion of which are inadvertently dialed by cell phone users.

"That's a significant drain for us," Lawson said. "That's a real emerging challenge."

He suggested cell phone users lock their key pads.

I believe you act as the secretary of the Police Services Board. As such I would ask that the following be put on the March agenda for discussion and reply.

For the better part of 2012 I was forwarding the OPP monthly reports to the Erin COPS committee. A few months ago at the Centre 2000 Management Committee, which is a joint committee with the town, county rep and the school board, following some discussion on vandalism I thought it would be valuable to forward the school board the OPP report, particularly the high schools' portion, being that the OPP has an officer in every high school.

It appears that the school board reps, the principal, and trustee were not aware that these reports existed and had some concerns with regards to consistency of data collection between and amongst the various schools. I believe they made some of these concerns known to Acting Inspector Susan Gray. With this email I am asking that a fair and consistent approach be taken in assessing, evaluating and reporting these incidents in the high schools, if such a process currently is not in place. In other words it would be nice to be able to compare apples to apples because the concern is the crime stats are very high in Erin in comparison to the other schools' population bases. When one looks at it appears that Erin District High School has a higher incident rate per capita than other schools evaluated and that is a concern for the school board as well.
